



# \$100 REBATE REWARD

## Terms and Conditions

Congratulations! You have received a Gas Pass Reward Certificate ("Reward Certificate") and are eligible to receive a Rebate Reward ("Rebate Reward"). The following terms and conditions describe the Gas Pass Rebate Reward Program (the "Program"), and how you can benefit from your Rebate Reward.

### Basic Description of the Program

The basic description of the Program is as follows (note that additional restrictions and procedures are described below):

1. You send Gas Pass Rewards ("we" or "us") a signed Registration Form at the address designated in the Reward Certificate and a Money Order in the amount of \$6.95 U.S. dollars for processing by certified or registered mail.
2. Once we receive and accept the Registration Form and money order, we will send you a gas rebate coupon ("Rebate Coupon");
3. You buy gas at the provider you designated in the Registration Form, then, within seven (7) days of your last purchase of gas, you send us a completed original Rebate Coupon and your receipts for gas you have purchased in the past 30 days, as well as an additional self-addressed, stamped envelope (or self-addressed envelope and international reply coupon);
4. Once we receive and accept the completed Rebate Coupon and receipt(s), we send you a Rebate Reward in the form of a \$25 check or gift card, along with your next Rebate Coupon; and
5. We will continue sending you Rebate Coupons for the number of months equal to the face value of your Reward Certificate divided by 25, and you may be eligible for Rebate Rewards, as long as you adhere to the conditions of the Program.

**Note that acceptance of the Registration Form and Rebate Coupon is subject to your adherence to all of the terms and conditions of the Program.** By submitting your signed Registration Form, you acknowledge your acceptance of ALL the following terms and conditions described herein.

### General Requirements

**Registration Form.** The Registration Form must be received no later than 21 calendar days of the issue date of the Reward Certificate or your Reward Certificate and your participation in the Program will be null and void.

**Minimum Purchase.** In order to qualify to receive your check or reward card, you must purchase a minimum of \$100 of gas per 30 day period at the Gas Pass Rewards-approved gas station that you selected in your Registration Form. Failure to do so renders your participation null and void.

**Receipts.** In order to be accepted, you must submit original receipts, which must be dated between the 1st through the 30th of a given month. Copies of receipts or other proof of purchase will not be accepted. All receipts must include the last 4-digit number of the credit card you designated on the Registration Form in order to be accepted as a valid receipt. You must use the same credit card for all gas purchases or your participation is null and void.

**Timeline.** Rebate Coupons and receipts must be mailed within 7 days of the date of your last purchase of gas within the relevant 30-day period and within all designated time frames or null and void.

**Correspondence.** If you send multiple envelopes to us all at once, none of these will be accepted and will render your Reward Certificate and your participation in the Program null and void. Failure to mail correspondence by certified or registered mail or failure to include the self-addressed, stamped envelopes (or, if applicable, international reply coupon) will render your Reward Certificate and your participation in the Program null and void, and no other Rebate Coupons will be issued.

**Rebate Coupons; Rewards.** The maximum number of Rebate Coupons that we may issue to you is determined by dividing the reward value amount on your Reward Certificate by 25. Rebate Coupons will not be replaced if lost, stolen or submitted other than in compliance with these terms and conditions. Once a Rebate Coupon is accepted by us, you will be entitled to receive a \$25 Rebate Reward in the form of a check or gift card for the brand of fuel that you selected in your Registration Form.

**Limit on Redemptions.** Only one Rebate Coupon can be redeemed within a 30-day period. If multiple Rebate Coupons are submitted during the same 30-day period only one will be redeemed, and any amount of rebate otherwise remaining will be rendered null and void, and you will not be issued any additional Rebate Coupons and your participation in the Program will be null and void.

**Non-transferable; No Cash Value.** Your Reward Certificate and any Rebate Coupon are non-transferable, **CANNOT** be resold and have no cash surrender value. Rebate Coupons must be used by the primary recipient, are non-transferable and cannot be divided among multiple users. If the Reward Certificate was purchased, or used to replace a gas rebate program other than Gas Pass Rewards or resold by you or any other party, your Reward Certificate and your participation in the Program will be null and void – without exception. Any fuel retailer, including the fuel retailer you have selected, will not directly accept Rebate Coupons.

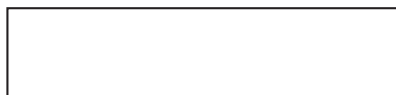
