

Terms & Conditions

Congratulations! You have been awarded one of the finest cruise awards. Below you will find the terms & conditions regarding this promotional certificate. These terms are important to you in the processing of your reservation. Please carefully read them in their entirety.

1. This offer is valid for a 7 day cruise for two adults (double occupancy required) in low season. The cruise entitles the recipient to leave out of Los Angeles, CA, San Juan, PR, Galveston, TX or Miami, FL. Accommodations are for an entry level stateroom. Accommodation, length of cruise and other departure port upgrades are available for a surcharge. To be eligible for this offer participants must be 21 years of age or older with a valid driver's license and a major credit card. All travelers must have a valid passport. 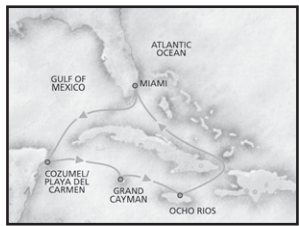

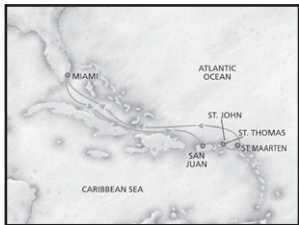

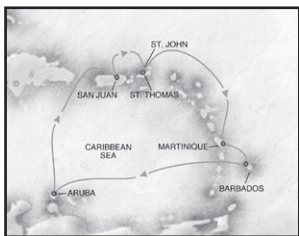
